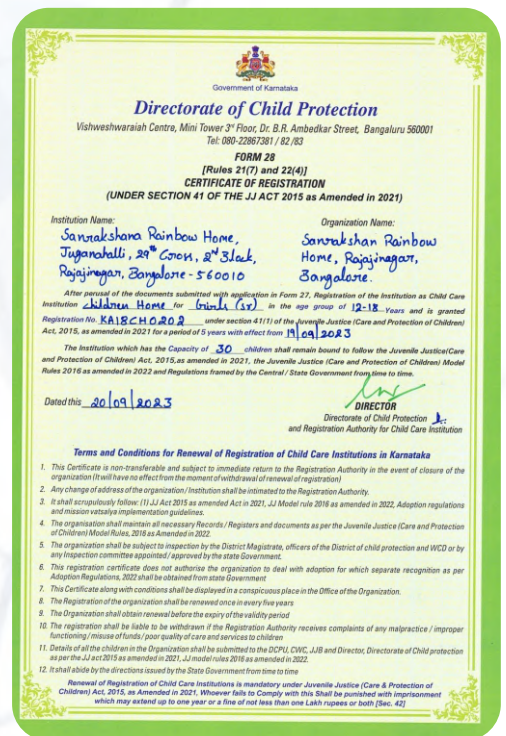
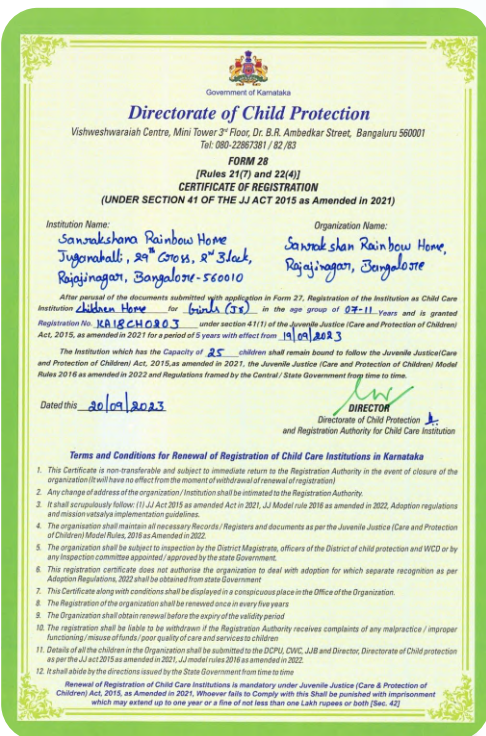


# Legal Status

Sanrakshan fulfills all statutory requirements, including registration under the Societies Act, registration under the Income Tax Act (including 80G and 12A), enrollment in the Darpan2 portal of NITI Aayog, and compliance with CSR Regulations under the Companies Act 2013. Our projects align closely with the Indian government's Children's Policy 2013, the Samagra Shiksha Abhiyaan, the Integrated Child Protection Scheme (ICPS), and the National Education Policy 2020, which aim to provide universal elementary education and social protection to all children, among other objectives.

# Certifications/Appreciation

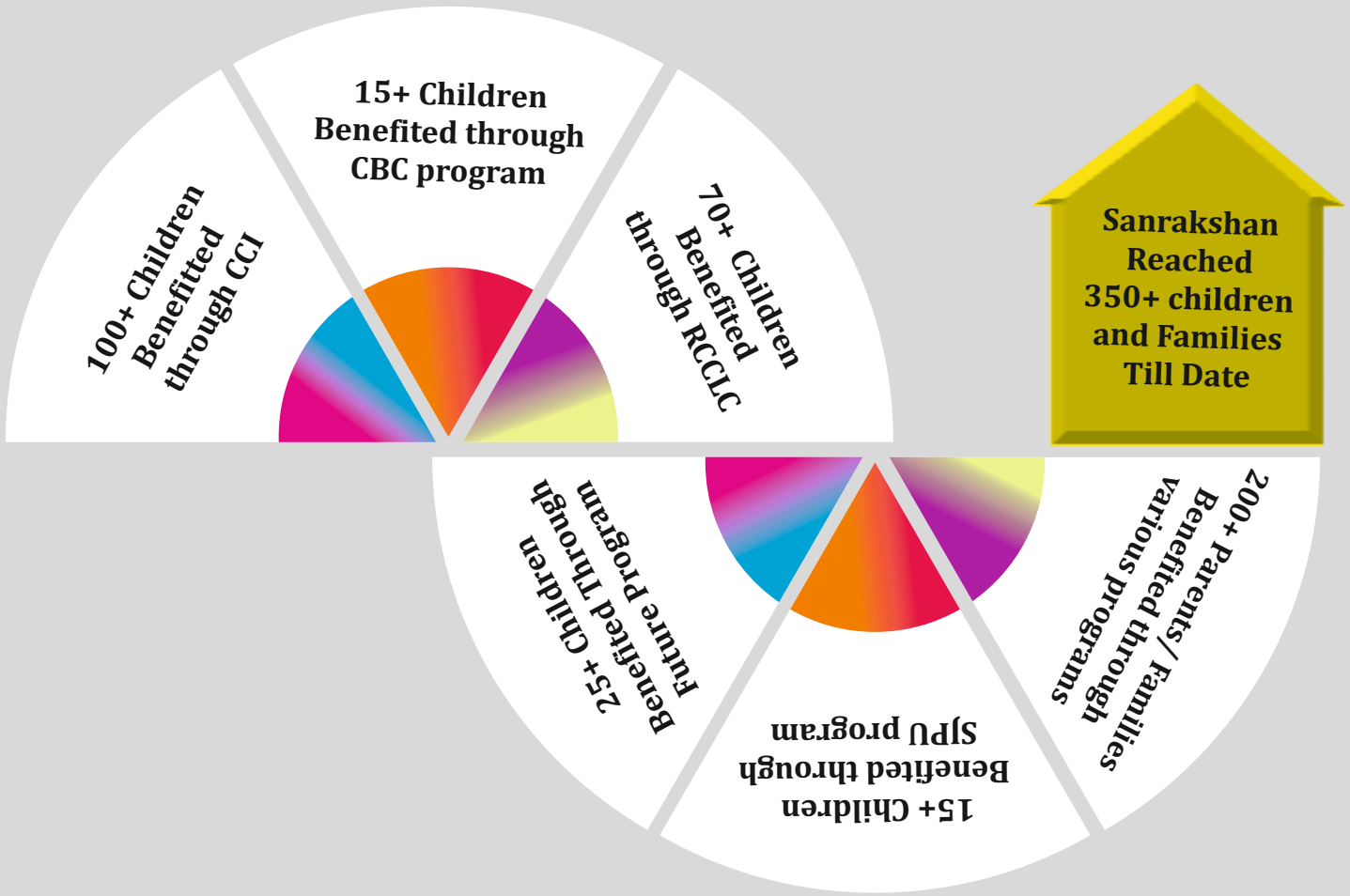

## What is Sanrakshan Rainbow Home Programs



# Highlights of year 2023-24

- The national team from Rainbow Foundation India organized a Children Participatory Review and Reflection Training program for all partner NGOs in Bangalore. Ms. Srilatha, Senior Program Manager, Mr. Babu, MIS Manager, and their team visited Sanrakshan Rainbow Home and oriented 30 children from five Rainbow Homes. The process extended over three days across different homes at the state level.
- With the support of Local MLA Mr. Suresh Kumar, we organized an Income and Caste Certificate Camp at Sanrakshan Rainbow Home on October 10th, 2023. We submitted applications for 41 children and successfully received the certificates. Now, 80% of the children at Sanrakshan Rainbow Home possess Income and Caste Certificates.
- With the support of UNICEF and Child Rights Trust, the children of Sanrakshan Rainbow Home had the opportunity to visit Chinnaswamy Stadium. They interacted with and participated in cricket activities alongside the Australian cricket team. Additionally, the children received a set of cricket tools.
- All four SSLC students have successfully passed their exams with commendable marks: Komalakshi (74.4%), Aishwarya (70.24%), Sridevi (63.52%), and Lakshmi (46.88%).
- The Labor Department of Karnataka hosted an event on June 12th at the Rajiv Gandhi statue to raise awareness and take action against child labor. Children from SRN Home actively participated in the event and had the honor of meeting our esteemed Chief Minister, Mr. Siddaramaiah.
- We are delighted to announce that Sanrakshan has successfully completed its remarkable four-years journey.
- The success of Chandrayaan-3 was celebrated by organizing a live show of the Chandrayaan-3 Moon Landing for all the children. Additionally, an educational session was conducted. The communication team from Smile Foundation visited Sanrakshan Rainbow Home, where the videographer captured the children's excited reactions during Vikram's moon landing.
- On September 11th, 2023, we underwent a safety and security audit conducted by the Rainbow Foundation India (RFI). Ms. Shubhadha and Ms. Sathya inspected the organization's infrastructure (such as safety grills, CCTV arrangements, security staff allocation, dormitory rooms, suggestion box, etc.), assessed the staff's knowledge, and interacted with the children.
- We organized a one-day camp to assist parents of the children at Sanrakshan in applying for the Aayushman Bharath Scheme. A total of 39 parents benefited from the scheme, which primarily focuses on providing healthcare services to economically disadvantaged sections of society.
- In honor of Mahatma Gandhi, we organized the "Under the Stars" program aimed at supporting individuals and families living on the streets, in railway stations, bus stops, and slums. In total, we supported over 60 individuals and families by providing dry ration kits, blankets, cooked meals, and sanitary napkins.

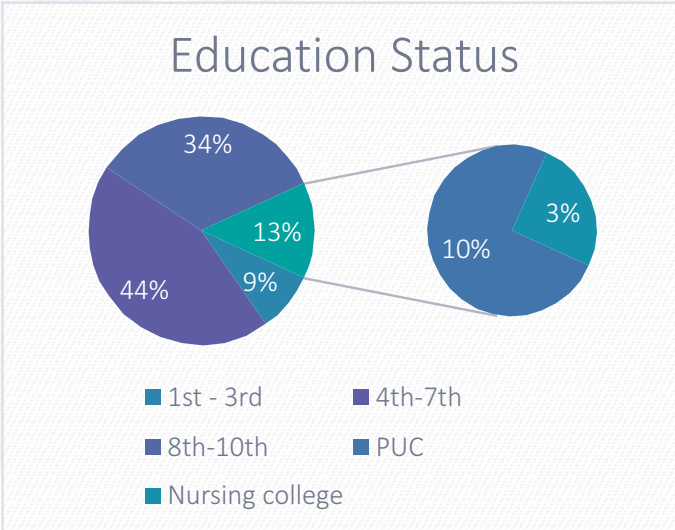
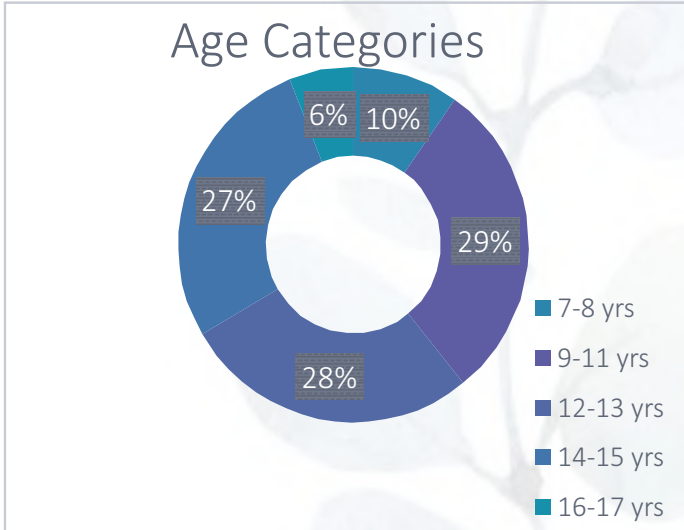


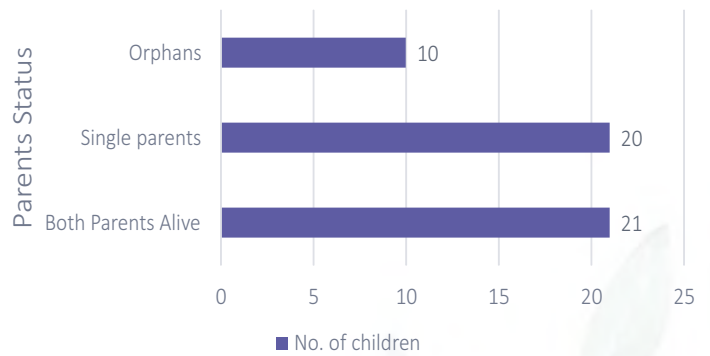
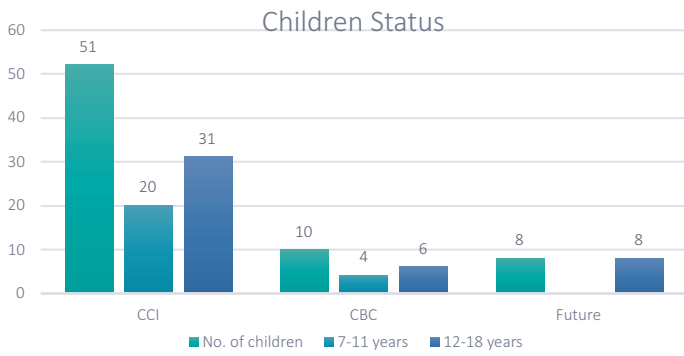
# Programme 1

## Empowering Street and Vulnerable Girls children through Child Care Institution in Bangalore



Sanrakshan operates a Child Care Institution (CCI) at Government Higher Primary & High School Juganahalli Rajajinagar, Bangalore for the past Four years. The approach is non-custodial, participatory, and inclusive. The CCI provides shelter, schooling, medical, and counseling support to 51 girls aged 7-18 from vulnerable backgrounds. These girls' Parents work as domestic workers or casual laborers. The CCI meets a significant need within vulnerable families in the surrounding community. Children receive healthy meals, monitored schoolwork, and remedial classes, and are involved in managing the CCI through committees. Special days and birthdays are celebrated, and yoga and meditation sessions are held daily, along with Quarterly health check-ups and outings for educational purposes. A Child Protection Committee and individual care plans are in place, along with quarterly Parents' Day and counseling sessions. Weekly online English classes and an annual summer camp are also provided.





# Activities



## A. Yoga/Exercise

“Yoga is a journey that one takes from self to self and through self.” Yoga and exercise among children are essential for their physical and mental well-being. Regular practice of yoga and exercise helps in improving flexibility, strength, and balance, while also promoting relaxation and reducing stress. We Incorporated yoga and exercise into children's daily routines in the morning 6AM to 7AM which lead to better concentration, improved mood, and overall health. Children of Sanrakshan are trained extensively and perform all of the asanas which helps them maintain a healthy lifestyle.



## B. Education

Knowing the Critical Importance of Education in Empowering Girl Children, especially those facing adversity and vulnerability.

We sponsored the regular school education of each Child by covering their minimal school fees, uniforms, books, and other educational expenses. In the evening we offered tutoring and remedial classes with the help of Qualified teachers to children as an extra support to excel academically.



## C. Extra Curricular Activities

Extracurricular activities offer a holistic approach to child development, nurturing not only academic skills but also social, emotional, and physical well-being. They provide valuable experiences and opportunities that contribute to a child's growth, success, and happiness both during childhood and beyond. To ensure Children's livelihood we engaged volunteers and allotted particular time for the activities.

## D. Nutrition

At the CCI, we are committed to ensuring the well-being and health of every child under our care. One significant aspect of this commitment is providing comprehensive nutritional support. Over the past years, we have implemented various initiatives to ensure that every child receives adequate and balanced nutrition. With the generous support of Raise against Hunger India, we have been able to offer a diverse range of nutritious meals to the children. These meals are carefully planned to meet their dietary needs and support their overall growth and development.



The meals of children included non-vegetarian options once a week and eggs twice a week. Additionally, children received a variety of nutritious items such as seasonal fruits like jackfruit, mango, and papaya, as well as seeds, eggs, protein-rich foods, milk, nuts, Chikki, dried fruits, and more, provided during evening snacks with the aid of the food committee.

## E. Health & Hygiene

Prioritized health and hygiene among children in CCIs is essential for their overall well-being, development, and future success. By fostering a culture of cleanliness, promoting healthy habits, and providing access to necessary resources and support, We created environments where children can thrive and reach their full potential.



In order to ensure the Good health and well-being of each child we organized quarterly health camp by inviting gynecologists, ophthalmologists, dentists, pediatricians, and general physicians with the help of supporting NGO doctors for Seva.

## F. Mental Health and Wellbeing

### a. Emotional Wellbeing Sessions with Home Children:

- Children regularly underwent in-depth and solution-focused counseling sessions during the academic year that exclusively provided one on one attention to the children catering to understanding their growing needs while focusing on their holistic development.
- Specific intervention and mentoring is carried out for children when referred by staff as and when there were behavioural problems noticed. These sessions included Behaviour Modification Techniques along with empathetic spacing for children to voice out their views and also become mindful.
- Counseling Sessions for children with emotional difficulties that were highlighted during these times were incorporated to help children think realistically and support them resolve complex problems through healthy coping.



- Children to be produced to CWC in these months for follow-ups had case-specific psychotherapeutic interventions as directed by CWC orders which needed counseling sessions to be conducted.

## **b. Group Therapy Sessions**

- The idea of having group interventions every month is to build support systems in a group setting for improvised interpersonal relationships and effective coping strategies. These sessions include groups that are age-specific to discuss and build insights for cohesiveness between children and create awareness, emotional regulation, and healthy self-concept.
- Group Interventions are therapeutic activities via storytelling, art-based techniques, visual imagery, play techniques, role play, etc.

## **c. Ted Talks and Psycho-Education**

- Ted talks and psycho-education is a part of well-being and is regularly conducted. Insight-building sessions include social health, personal hygiene, motivation, confidence-building, mindfulness, and emotional regulation.

## **d. Solution Focused Interventions**

- Facilitation and Mediation during Balasabha and Children Committee Meetings that help focus on a child centric approach. Children and staff related problems may require immediate attention and solutions proposed are adopted with mutual agreeableness. Group meetings also focus to explain roles and responsibility to children while psycho-educating them for discipline.

## **e. ZEN Sessions by Prakruthi Foundation**

- ZEN is an Counselling Session which bottom-up theory of processing trauma addresses traumatic stress by bringing awareness to sensations and implicit, nonverbal experiences. team from Prakruthi Foundation regularly visited Sanrakshan Rainbow Home and intervened children traumatic condition by Psycho-education, Window of Tolerance, Somatic exercises, Art based therapy, and Mindfulness.

## **Celebrations**

Celebrating special days with children holds significant importance for several reasons like Sense of Belonging, Promotion of Cultural Awareness, Emotional Well-being, Building Memories, Educational Opportunities, Social Interaction, Sense of Normalcy and Routine, Encouragement of Creativity and Expression. Celebrations are not only a fun and enjoyable experience but it also creates a positive and nurturing environment where children can thrive and create cherished memories that last a lifetime.



We As a non-secular organization have equally respected all religions and Celebrated every festival like Ramzan, Christmas, varamahalakshmi, Ganesh Chaturthi, and so on. We also give awareness to the children on special observational days like Ambedkar Jayanti, Independence Day, Republic Day, children in street situations, Women's Day, Children's Day, Day against child labour and so on.

## Exposure Visits

1. Plan Source Company Organized a Corporate visit to the Children of Sanrakshan Rainbow Home. Employees of the Company organized Plenty of Activities and Games to all the children and they also provided Prizes to the Winners. In Addition, they also Provided Donation and Care kits to each Child. Children Enjoyed the fun-filled day.
2. With the help our CPC member we organized an exposure visit to the Children of SRN Home to Vidhan Soudha Children got a chance to observe the Assembly, in addition to that they also observed the Karnataka Rajya Aadhiveshana (Karnataka Legislative Council).
3. Bhoomi Organization organized a Child Centric event “ Nakshathra” by gathering all the children from different Child Care intuitions and conducted Drawing, Dance, Craft making and Singing Competition, wherein Children of Sanrakshan Rainbow Home wone in few competitions and got the prizes.
4. We organized all the children’s Visit to Rajajinagar Police Station on 20th April Ms.Geetha (PSI) helped the children to explore the Infrastructure of the Police station,and educated them more about the laws and the actions to be undertaken in the police station.
5. We took senior Children of Sanrakshan Rainbow Home to BorgWarner Company as an exposure visit to make them understand the manufacturing process of electric cars and other vehicles. All the team members and the Heads led the International Women's Day celebration at the company alongwith all the children by organizing few educational sessions as well as fun activities. In addition to that they also invited an famous Gynecologist and organized a session on Menstrual health and hygiene practices.

# Programme 2

## Serving the Marginalized Communities

### 2.1 Family-Based Care

Through Family-Based Care we Support vulnerable children and families below the poverty line and in marginalized communities, including educational assistance, counseling, motivation, and personality development. Placement will be sought with parents or extended family members whenever possible for children who can thrive in a family environment. Kinship Care involves placing children with extended family or close family friends to minimize disruptions to their lives, with support provided to care givers until the child turns 18. Progress will be monitored closely, and support will be provided to ensure access to education, holistic development, and emotional well-being. Comprehensive records will be maintained for children placed for adoption.

### Distribution of Dry ration Kits

In response to our ongoing project supporting children and families under a community-based care program, we initiated the distribution of dry ration kits monthly. These kits contain essential food items aimed at providing suspense and relief to those in need during these trying times. Each Ration kit is carefully curated to ensure that it meets the nutritional requirements of children. The Contents typically include staple food items such as rice, lentils, flour, cooking oil, sugar, salt, and basic spices.



### Health

In Child Care Institution with the support of Aster CMI And Doctors for Seva organization we have organized Quarterly health camp in the Month of April, August, and March focusing on children's health. Wherein all the 10 CBC Children were thoroughly examined by the Different specialist doctors like ophthalmologists, gynecologists, Dentist and many other. were contacted for an examination pertaining to children's health, during which general practitioners, eye exams, and measurements of the children's height and weight were taken.



Every child and Parent has been educated on the Importance of Health and hygiene in daily life during Home visit.

Regular education was given on the elimination of Stigma during Menstruation and other communicable disease.

## Life skill sessions

We conducted life skill sessions tailored specifically for the parents of the children under the community-based care program. The sessions are designed to empower them with the practical tools and knowledge that will enhance their ability to navigate life challenges and nurture the well-being of their children and families. During the home visit our CBC coordinator conducted sessions and embarked on the journey of the parents as well as the children.



The awareness sessions conducted to parents on their roles and responsibilities in taking care of children, the importance of documents and entitlements, personal hygiene practices, the importance of education in the community, and challenges faced by children due to child marriage and child labor.

## 2.2 Rainbow Community Care Learning Centre

We operate a community learning center to provide bridge courses and remedial classes for children from the Kole Basava community who left formal schooling, aiming to reintegrate them successfully. Since January 2022, we've had a dedicated teacher ensuring effective functioning. Our goal is to reintegrate every child into nearby government schools, offering after-school Remedial Classes emphasizing academic and life skills development. We also form Parents Collectives to facilitate access to entitlements and support families in obtaining essential documents and accessing various schemes.





## Education

We reintegrated every child in the community into nearby government schools. Recognizing the need for after-school support, the program includes planned Remedial Classes for each child in the evenings. An exclusive coordinator has been recruited to oversee these educational aspects and provide support to children with their academic syllabus.

In addition to academic support, the program emphasizes life skills development. Regular sessions are planned and organized based on Social, Physical, Emotional, Intellectual, and Creative Development. The initiative also identifies and nurtures individual talents among the children in the community. Efforts are made to collaborate with local organizations that provide services to support and enhance these talents.



## Formation of Parents Collectives

A crucial aspect of the program involves the formation of Parents Collectives, with the aim of including parents/guardians of all community children. These collectives serve as platforms for orientation sessions on entitlements. Subsequently, these collectives play a facilitative role in helping community members access eligible schemes and entitlements. The program provides essential support to families and communities in obtaining identity documents and accessing various schemes such as Aadhar, bank accounts, voter IDs, pensions, ration cards, and more.



## Health Care

The team of Rainbow Foundation India Organized a Mental Health Awareness Program in the Kole Basava Community at Rayasandra. Resource persons Ms. Gracy and Ms. Varalaxmi (Psychology Therapist) gave an awareness aimed at reducing the stigma associated with mental Health Issues and educated the coping strategies to all the community participants. In the Community with the support of Local PHC, we examined 6 Pregnant Women were examined for their Hemoglobin, and 20 Children were provided with Vitamin A Syrup On 18th July 2023 we organized Tuberculosis Awareness Camp in the Community and educated them about the Prevention Methods

We organized the Health Camp at Community Care Learning Centre, Rayasandra on 16th March 2024, which aimed to provide essential healthcare services and raise awareness about preventive measures among the community members. It was organized in collaboration, with Doctors for Seva to address the healthcare needs of the community Children. A total of 18 health Care providers screened the children with various conditions like Dental, Dermatology, Gynecologist, General A Health Checkup, Blood Group Identification, and Hemoglobin test were done. In addition to that team also gave a Health Education Session on Genital Health for Boys and Menstrual Health for girls



## Programme 3 Future Programme

The Futures program is designed to address the myriad transition challenges that young adults face when they leave child care institutions at the age of 18. This initiative aims to empower these individuals by providing comprehensive skill development and sustained aftercare support, thereby fostering both personal and professional growth. We tackle issues such as unemployment, skill gaps, and limited support systems through a multifaceted approach. By partnering with businesses, we facilitate job placements, and offer career counseling and resume-building workshops. Additionally, we collaborate with educational institutions to provide continuing education opportunities, including scholarship programs. This holistic strategy ensures that young adults are equipped with the tools and support necessary for a successful transition into independent adulthood.

### Life Skill Sessions for the young adults

Life skill sessions are instrumental in preparing young adults for the myriad challenges and opportunities they will encounter across various facets of life. These sessions provide a comprehensive toolkit that includes practical skills, personal development strategies, and the confidence necessary to thrive. By focusing on essential areas such as financial literacy, effective communication, time management, and problem-solving, we ensure that participants are well-equipped to handle real-world situations. Additionally, these sessions foster

emotional intelligence, resilience, and self-awareness, which are critical for personal growth and successful interpersonal relationships. Ultimately, life skill sessions lay a strong foundation for a fulfilling and prosperous adulthood, empowering young adults to navigate their future with competence and confidence.



### Exposure Visit

Exposure visits provide young adults with invaluable opportunities to broaden their horizons, gain new insights, and develop essential life skills. These experiences significantly contribute to their personal, academic, and professional growth by allowing them to explore diverse environments and cultures. Through exposure visits, participants can witness different ways of life, understand various professional fields, and appreciate the richness of diverse communities. Such

experiences help in broadening their perspectives, fostering open-mindedness, and enhancing adaptability. Moreover, these visits nurture fundamental skills such as critical thinking, problem-solving, and effective communication. By immersing young adults in new and varied settings, exposure visits play a crucial role in shaping well-rounded individuals who are better prepared to navigate and succeed in an increasingly interconnected world.



## Programme 4

### Special Juvenile Police Unit (SJPU)

In collaboration with the District Child Protection Unit, Sanrakshan is actively engaged with 32 police stations across Bengaluru and the Department of Police to rescue children from a variety of perilous situations, including domestic conflicts, homelessness, abuse, and trafficking. Sanrakshan plays a crucial role in supporting the Special Juvenile Police Unit by providing essential counseling services and guiding legal procedures for juvenile offenders and children in need of protection. This comprehensive effort aims to assist at least 150 children in the Central and West Divisions of Bengaluru per year. Additionally, the project places a strong emphasis on raising community awareness and empowering children who are involved in legal cases, ensuring they receive the support and advocacy they need to navigate their challenges effectively.

## Programme 5

# Mentoring, career guidance, and scholarships for financially disadvantaged girl students

Through this project, we aim to support girls from financially weaker sections in Chikkaballapur and Doddaballapur in Karnataka by providing mentoring, career guidance, and scholarships. Recognizing education as a fundamental right, we address the gender inequality prevalent in India, where many girls are denied education due to socio-economic constraints. Over 50% of Indian girls discontinue their education due to financial reasons. Our scholarships cover college fees, tuition, books, and other expenses, empowering girls to pursue their academic and career goals. Through mentorship and financial support, we aim to foster personal growth, skill development, and contribute to the overall advancement of society.

In line with our commitment, we have prepared a proposal for a new project that focuses on providing scholarships specifically for science students in the Chikkaballapur and Doddaballapur districts of Karnataka. As part of this initiative, we conducted a preliminary survey by visiting government PUC colleges in Chikkaballapur city on July 21st and 22nd to collect college data. This project is being implemented through a collaboration between United Way Bengaluru and Sanrakshan, with technical support to ensure its success. The CSR funds for this initiative have been released through Collin Aerospace, underscoring the significant corporate support for this cause.

### Objectives of the Project

- To identify Girls from economically weaker sections to excel in studies, develop values and like skills and identify career path.
- To encourage children in attending regular CET/JEE/NEET Coaching classes
- Secure admission in nearby Colleges or schools / support students from weaker sections who are already enrolled in the schools and Colleges.
- Provide English-speaking, computer courses, and subject-specific coaching classes.
- Organize round-the-year personality development, life skills and value education program



## Advocacy/ Networking

Advocate and networking are indispensable tools for NGOs Striving to make a meaningful impact in society. By effectively advocating for their causes and establishing strategic networks, Sanrakshan amplified the voices, mobilizing resources and catalyzing positive change. Strong advocacy we built awareness among the population about the vulnerability of the children that we are serving. Through networking, we mobilized resources, exchanged knowledge, and implemented the program with collective actions. We have built a good network with the DWCD, the local MLA, the education department, the school administrations, the CWC, the DCPU, police stations in West and Central divisions and the surrounding community. In addition, BEO, DCPO and CWC Members also Visit the Home regularly.

## Governance and Administration

The Governing Body Meeting was held on the 27th of May 2023 and the agenda was followed as Accepting the Annual report, Audit report and appointment of Chartered accountant. The annual General Body Meeting was held in 19th of June 2023 and the agenda discussed society renewal and registration of Child Care institutions.

In the second Governance body meeting Mr. Rajashekhar M Invited 3 New Board Members Ms. Rachamma, Ms. Mahadevi, and Ms. Roopa H S. The inclusion of new members added depth and diversity to the Board, enriching SANRAKSHAN collective expertise. The Discussion further continued on brief of organization activities, Financial statements, and Progress on the FCRA Certificate.

## CASE 2



### **The high spirit to never give up**

Fathima was a little baby when her father abandoned the family and left. Her mother single handedly raised the child until she fell sick and was diagnosed with blood cancer. The child took care of her ailing mother until she succumbed to the disease and passed away. A family friend came in to take Fathima's responsibility and everything seemed settling for the little girl until they began to ill treat Fathima and was mostly asked to do house chores instead of study and play. The said guardians of Fathima couldn't keep her anymore and came to the police for help and dropped her at CWC.

A scared, rebellious Fathima not having to experience nurturance and affection was termed a “problematic child” until she stepped into to Sanrakshan Rainbow Home. Constant encouragement, care and love, Fathima changed to be the a good child whose developmental growth depended on feeling belonged and safe. She no longer was the problematic child but instead started being responsible, being a leader and a good performer at school.

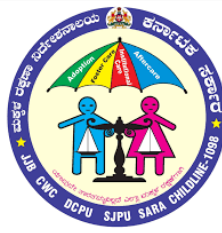

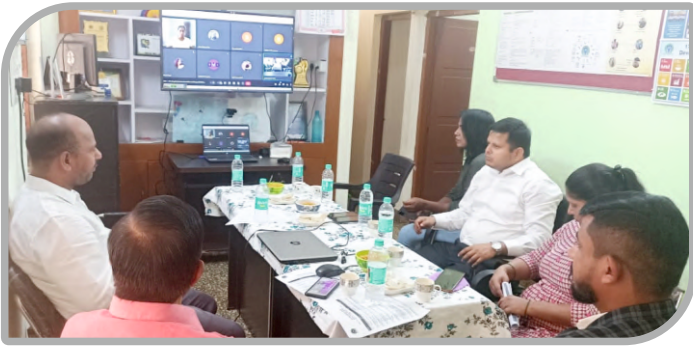

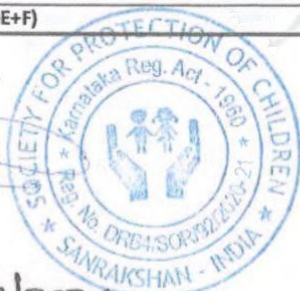
